Majority OTP-AM Accepted 06/30/93 (Minority ONTP). Amended by: CA (Changed Title) H-702, SA/CA S-360. Enacted, Signed 07/13/93, P & S LAWS, Chapter 51. Final Disposition: Approved in Referendum 11/02/93 (In favor: 149,673; Opposed: 82,488).
