Referred to Joint Standing Committee on Utilities. Public Hearing 03/29/93. Majority OTP-AM Accepted 06/01/93 (Minority ONTP). Amended by: CA H-472. Enacted 06/11/93. Final Disposition: Veto Sustained 06/15/93.
