LD 1451 / HP1085

An Act to Restrict Private Political Campaign Contributions in State Elections. Presented by Representative RICHARDSON of Portland; Cosponsored by Representative CARLETON of Wells, Senator HANDY of Androscoggin and Representatives: BARTH of Bethel, BOWERS of Washington, BRENNAN of Portland, CAMERON of Rumford, DONNELLY of Presque Isle, FARNSWORTH of Hallowell, KILKELLY of Wiscasset, TUFTS of Stockton Springs, YOUNG of Limestone, Senators: HALL of Piscataquis, McCORMICK of Kennebec. Referred to Joint Standing Committee on Legal Affairs. Public Hearing 05/06/93. House: Accepted Majority ONTP 06/08/93; Senate: Indef. Postponement 06/09/93. Final Disposition: Died Between Houses 06/09/93.
