Original Title: Resolve, to Establish the Health and Social Services Transition Team to Develop the Governor's Restructuring Proposal to Combine the Departments of Human Services and Mental Health and Mental Retardation and the Office of Substance Abuse in a New Department of Health and Family Services. New Title: Resolve, to Abolish the Department of Human Services and the Department of Mental Health and Retardation and Create a New Department of Health and a New Department of Children and Families. (GOVERNOR'S BILL). Presented by Representative REED of Falmouth; Cosponsored by Representatives: BRUNO of Raymond, DiPIETRO of South Portland, YOUNG of Limestone, Senator: BERUBE of Androscoggin. Referred to Joint Standing Committee on Human Resources. No Public Hearing. Majority OTP-AM 06/04/93 (Minority OTP-AM). Amended by: CA (Changed Title) H-516, HA/CA H-600, SB/CA S-314. Final Disposition: Emergency Finally Passed, Signed 06/24/93, RESOLVE LAWS, Chapter 36.
