LD 1530 / HP1129

An Act to Continue the 2-cent Gas Tax Increase. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.) Presented by Representative STROUT of Corinth; Cosponsored by Senator BRANNIGAN of Cumberland and Representatives: BAILEY of Township 27, DRISCOLL of Calais, GOULD of Greenville, HICHBORN of Howland, HUSSEY of Milo, LORD of Waterboro, MARTIN of Van Buren. MELENDY of Rockland, MICHAUD of East Millinocket, MORRISON of Bangor, NORTON of Winthrop, O'GARA of Westbrook, PLOURDE of Biddeford, REED of Dexter, RICKER of Lewiston, TARDY of Palmyra. Senators: CIANCHETTE of Somerset. GOULD of Waldo. House: Insist on Engrossed Without Reference 05/26/93. Senate: Indef. Postponed 06/30/93. Final Disposition: Died Between Houses 06/30/93.
