LD 1542 / HP1142

An Act to Encourage Implementation of Total Quality Management Procedures in the Executive Branch of State Government. (GOVERNOR'S BILL). Presented by Representative GWADOSKY of Fairfield; Cosponsored by Senator BUTLAND of Cumberland and Representatives: AULT of Wayne, CHASE of China, CLEMENT of Clinton, DAGGETT of Augusta, FARNSWORTH of Hallowell, HALE of Sanford, HATCH of Skowhegan, KONTOS of Windham, PARADIS of Augusta, ZIRNKILTON of Mount Desert, Senators: BUSTIN of Kennebec, CARPENTER of York, DUTREMBLE of York, ESTY of Cumberland. Referred to Joint Standing Committee on State and Local Government. Public Hearing 06/01/93. Majority OTP-AM Accepted 06/04/93 (Minority ONTP). Amended by: CA H-581, HB H-637. Final Disposition: Emergency Enacted, Signed 07/13/93, PUBLIC LAWS, Chapter 476.
