No Public Hearing. OTP-AM Accepted 03/28/94. Amended by: CA (Changed Title) H-949, SB/CA S-639. Enacted, Signed 04/20/94, PUBLIC LAWS, Chapter 722. Final Disposition: Approved in Referendum 11/08/94 (In favor: 249,699; Opposed: 233,784).
