An Act to Authorize the Towns of Appleton, Camden, Hope, Lincolnville and Rockport to Form a Community School District. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by Representative WHITCOMB of Waldo; Cosponsored by Representatives: BOWERS of Washington, NASH of Camden, Senator: PINGREE of Knox. Referred to Joint Standing Committee on Education.
