LD 1756 / HP1301

An Act to Authorize a Department of Inland Fisheries and Wildlife Bond Issue of \$10,000,000 for Fish Hatcheries. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by Representative ROTONDI of Athens; Cosponsored by Representatives: CLARK of Millinocket, FARREN of Cherryfield, GREENLAW of Standish, HEINO of Boothbay, JACQUES of Waterville, LARRIVEE of Gorham, MICHAUD of East Millinocket, NICKERSON of Turner, REED of Falmouth, SPEAR of Nobleboro, SWAZEY of Bucksport, TRACY of Rome, Senators: HALL of Piscataquis, LUTHER of Oxford, O'DEA of Penobscot, PEARSON of Penobscot. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/02/94. OTP-AM Accepted 03/29/94. Amended by: CA H-962, HA/CA H-1037. Enacted, Signed 04/15/94, P & S LAWS, Chapter 90. Final Disposition: Failed in Referendum 11/08/94 (In favor: 238,092; Opposed: 249,142).
