LD 1898 / SP0700

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$21,000,000 to Provide Funds for Improved Access to State Facilities for Disabled Citizens and Employees, for Safety Improvements at the Baxter School for the Deaf and for Long-term Lease Cost Savings. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$2,000,000 for Safety Improvements at the Baxter School for the Deaf. (GOVERNOR'S BILL). Presented by Senator CARPENTER of York; Cosponsored by Representative REED of Falmouth and Senator: PEARSON of Penobscot, Representative: CARROLL of Gray. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/02/94. OTP-AM Accepted 03/29/94. Amended by: CA (Changed Title) S-538, SA/CA S-621. Enacted, Signed 04/14/94, P & S LAWS, Chapter 88. Final Disposition: Approved in Referendum 11/08/94 (In favor: 247,400; Opposed: 239,034).
