RESOLUTION, Proposing An Amendment to the Constitution of Maine to Provide for the Election of a Lieutenant Governor and to Provide for Succession to the Office of Governor. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.) Presented by Representative LEMKE of Westbrook; Cosponsored by Senator HANDY of Androscoggin and Representatives: AHEARNE of Madawaska, BENNETT of Norway, CARLETON of Wells, CARROLL of Gray, CLARK of Millinocket, COFFMAN of Old Town, DEXTER of Kingfield, GOULD of Greenville, JACQUES of Waterville, KILKELLY of Wiscasset, LIBBY of Kennebunk, MARTIN of Eagle Lake, MORRISON of Bangor, PARADIS of Augusta, REED of Dexter, TRACY of Rome, TUFTS of Stockton Springs.
