LD 1940 / SP0718

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$10,299,667 to Improve the Academic Facilities of the University of Maine System. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$5,000,000 for Academic Improvements at the University of Maine System, Including the Enhancement of Instructional Technology and Distance Learning. (GOVERNOR'S BILL). Final Disposition: Failed in Referendum 11/08/94 (In favor: 199,819; Opposed: 286,053).
