RESOLUTION, Proposing an Amendment to the Constitution of Maine to Reduce the Size of the Maine Legislature to 99 Members in the House and 33 Members in the Senate. Presented by Representative BUCK of Yarmouth; Cosponsored by Senator HARRIMAN of Cumberland and Representatives: BARTH of Bethel, JONES of Pittsfield, JOYCE of Biddeford, POVICH of Ellsworth, Senators: ABROMSON of Cumberland, MILLS of Somerset. Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/05/95. House: Majority ONTP Accepted 04/26/95, Adhere to Majority ONTP 05/09/95; Senate: Minority OTP-AM Accepted 04/27/95. Final Disposition: Died Between Houses 05/09/95.
