Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$13,000,000 for Landfill Closure and Remediation and for the Removal of State-owned Underground Storage Tanks. Final Disposition: Approved in Referendum 11/07/95 (In favor: 250,574; Opposed: 156,996).
