An Act to Create an Intermediate License for Minors. Presented by Senator FAIRCLOTH of Penobscot; Cosponsored by Senators: CASSIDY of Washington, PARADIS of Aroostook, STEVENS of Androscoggin, Representatives: CHARTRAND of Rockland, O'GARA of Westbrook. Referred to Joint Standing Committee on Transportation. Public Hearing 03/29/95. Majority OTP-AM Accepted 06/19/95. Amended by: CA S-220. House: Enactment Failed 06/21/95; Senate: Indefinite Postponement 06/22/95. Final Disposition: Died Between Houses 06/22/95.
