RESOLUTION, Proposing an Amendment to the Constitution of Maine to Reduce the Size of the Legislature Following Redistricting in the Year 2003. Presented by Senator RUHLIN of Penobscot; Cosponsored by Senators: AMERO of Cumberland, CARPENTER of York, CIANCHETTE of Somerset, CLEVELAND of Androscoggin, LONGLEY of Waldo, Representatives: GOULD of Greenville, GREENLAW of Standish, POULIN of Oakland. Referred to Joint Standing Committee on State and Local Government. Public Hearing 03/08/95.
