An Act to Establish Qualifications for Public Utilities Commissioners. Referred to Joint Standing Committee on Utilities and Energy. Public Hearing 05/08/95. House: Majority OTP-AM Accepted, Insist on Majority OTP-AM 06/12/95, Conference Committee 06/12/95; Senate: Minority ONTP Accepted 06/08/95, Adhere to Minority ONTP 06/13/95. Final Disposition: Died Between Houses 06/13/95.
