Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 05/24/95. Majority OTP-AM Accepted 03/03/96. Amended by: CA S-517. House: Enacted 03/30/96, Insist on Enactment 03/30/96; Senate: Indefinitely Postponed 03/30/96, Adhere to Indefinite Postponement 04/01/96. Final Disposition: Died Between Houses 04/01/96.
