Presented by Representative DORE of Auburn; Cosponsored by Representatives: DAGGETT of Augusta, KONTOS of Windham. Referred to Joint Standing Committee on Human Resources. Public Hearing 05/09/95. House: Minority OTP-AM Accepted 06/07/95, Insist on Engrossment 06/13/95, Conference Committee 06/13/95; Senate: Majority ONTP Accepted 06/12/95, Adhere to Majority ONTP 06/13/95. Final Disposition: Died Between Houses 06/13/95.
