New Title: An Act to Authorize Department of Transportation Bond Issues in the Amount of \$58,900,000 to Match up to \$138,000,000 in Federal Funds for Improvements to Highways, State and Local Bridges, Airports and Ports. Amended by: CA (Changed Title) H-627. Enacted, Signed 07/03/95, PUBLIC LAWS, Chapter 498. Final Disposition: Approved in Referendum 11/07/95 (In favor: 289,614; Opposed: 121,983).
