An Act to Repeal the Requirement that Disbursement Warrants Receive an Affirmative Vote by Municipal Officers. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by Senator AMERO of Cumberland; Cosponsored by Senators: ABROMSON of Cumberland, CAREY of Kennebec, CARPENTER of York, CLEVELAND of Androscoggin, GOLDTHWAIT of Hancock, HARRIMAN of Cumberland, Representatives: DUNN of Gray, HARTNETT of Freeport, MARVIN of Cape Elizabeth, REED of Falmouth, SAXL of Bangor.
