(Submitted by the Department of the Secretary of State pursuant to Joint Rule 24.) Presented by Representative NADEAU of Saco. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 01/18/96. OTP-AM Accepted 02/27/96. Amended by: CA H-714. Finally Passed, Signed 04/03/96, CON RES LAWS, Chapter 3. Final Disposition: Approved in Referendum 11/05/96 (In favor: 367,994; Opposed: 187,428).
