An Act to Allow the Diagnosis of Biologically-based Mental Illness by Licensed Psychologists. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by Senator ABROMSON of Cumberland; Cosponsored by Representative POVICH of Ellsworth and Senators: AMERO of Cumberland, BUSTIN of Kennebec, CARPENTER of York, FAIRCLOTH of Penobscot, McCORMICK of Kennebec, MILLS of Somerset, PENDEXTER of Cumberland, SMALL of Sagadahoc, Representatives: BRENNAN of Portland, CAMERON of Rumford, DORE of Auburn, KONTOS of Windham, LIBBY of Buxton.
