An Act to Improve the Hancock County Budget Procedure. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.) Presented by Senator RUHLIN of Penobscot; Cosponsored by Representative POVICH of Ellsworth and Representatives: BIGL of Bucksport, BUNKER of Kossuth Township, FISHER of Brewer, JONES of Bar Harbor, PINKHAM of Lamoine. Referred to Joint Standing Committee on State and Local Government. Public Hearing 02/13/96. House: Minority OTP-AM Accepted 03/21/96, Engrossed as Amended by CA 03/21/96; Senate: Majority ONTP Accepted 03/21/96, Adhere to Majority ONTP 03/22/96. Final Disposition: Died Between Houses 03/22/96.
