An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government and to Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1996 and June 30, 1997. (GOVERNOR'S BILL). Referred to Joint Standing Committee on Appropriations and Financial Affairs. Several Public Hearings. OTP-AM Accepted 03/30/96. Amended by: CA H-892, HA/CA H-900. Final Disposition: Emergency Enacted, Signed 04/11/96, PUBLIC LAWS, Chapter 665.
