An Act to Amend the Laws Concerning Commercial Whitewater Rafting. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.)

Presented by Senator MICHAUD of Penobscot; Cosponsored by Representative: CLARK of Millinocket. Referred to Joint Standing Committee on Inland Fisheries and Wildlife.
