LD 1848 / SP0740

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$5,500,000 for Major Improvements at State Park and Historic Site Facilities and for the Public Access to Maine Waters Fund and the Land for Maine's Future Fund. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$3,000,000 for Major Improvements at State Park and Historic Site Facilities. (GOVERNOR'S BILL). Presented by Senator CASSIDY of Washington; Cosponsored by Senators: LORD of York, PARADIS of Aroostook, Representatives: DEXTER of Kingfield, HEESCHEN of Wilton, KERR of Old Orchard Beach, MARTIN of Eagle Lake, POULIOT of Lewiston, STROUT of Corinth. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/18/96. Majority OTP-AM Accepted 04/01/96. Amended by: CB (Changed Title) S-568. Enacted, Signed 04/10/96, P & S LAWS, Chapter 77. Final Disposition: Approved in Referendum 11/05/96 (In favor: 342,116; Opposed: 234,023).
