An Act to Ensure That Employees Are Compensated for Accrued Vacation Time in the Event of the Sale of a Business. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.) Presented by Representative TUTTLE of Sanford; Cosponsored by Representative HATCH of Skowhegan, Senator MILLS of Somerset and Representatives: CHASE of China, GWADOSKY of Fairfield, JACQUES of Waterville, JOY of Crystal, LEMAIRE of Lewiston, MITCHELL of Vassalboro, SAMSON of Jay, STEDMAN of Hartland, TYLER of Windham, Senators: BEGLEY of Lincoln, RAND of Cumberland.
