LD 1893 / HP1392

An Act to Conform the Maine Tip Credit to the Federal Tip Credit. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative KERR of Old Orchard Beach; Cosponsored by Senator AMERO of Cumberland and Representatives: CAMPBELL of Holden, FISHER of Brewer, TRUE of Fryeburg, WATERHOUSE of Bridgton, Senators: BUTLAND of Cumberland, FERGUSON of Oxford, STEVENS of Androscoggin. Referred to Joint Standing Committee on Labor. Public Hearing 09/04/96. Majority (OTP-AM) Accepted 09/05/96. Amended by: CA H-923, SA S-601. Enacted. Final Disposition: Held by Governor and Died at End of Session (Pocket Veto).
