An Act to Exclude Intentional Tort Claims from the Application of the Maine Workers' Compensation Act of 1992. Presented by Senator LaFOUNTAIN of York; Cosponsored by Representative DAVIDSON of Brunswick and Senator TREAT of Kennebec, Representatives: LEMAIRE of Lewiston, McALEVEY of Waterboro, WATSON of Farmingdale. Referred to Joint Standing Committee on Judiciary. Public Hearing 02/12/97. House: Indefinitely Postponed 03/27/98, Senate: Minority (ONTP) Accepted 03/27/98. Final Disposition: Died in Concurrence 03/27/98.
