An Act to Criminalize Certain Photographing of Children. Presented by Senator SMALL of Sagadahoc. Referred to Joint Standing Committee on Criminal Justice. Public Hearing 02/13/97. OTP-ND (New Title) Accepted 05/30/97. New Draft New Title: An Act to Criminalize Unpermitted Visual Surveillance under the Clothing of a Person in a Public Place by Mechanical or Electronic Equipment. LD 1892 / SP0664. Final Disposition: Enacted, Signed 06/11/97, PUBLIC LAWS, Chapter 467. (Note: Some New Draft references include an erroneous title, "An Act to Criminalize Certain Photographing of Children under the Clothing of a Person in a Public Place by Mechanical or Electronic Equipment"; this was never an authorized title.)
