Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$20,000,000 for Landfill Closure and Remediation. New Title: An Act to Authorize 2 General Fund Bond Issues in the Amount of \$13,000,000 to Construct Water Pollution Control Facilities, to Close and Clean Up Municipal Solid Waste Landfills, to Clean Up Tire Stockpiles, to Mitigate Storm Water Pollution through a Comprehensive Watershed Protection Program and to Make Drinking Water Improvements. Presented by Senator MICHAUD of Penobscot. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/04/97. OTP-AM Accepted 05/14/97. Amended by: CA (Changed Title) S-213, SC/CA (Changed Title) S-446. Enacted, Signed 06/25/97, PUBLIC LAWS, Chapter 561. Final Disposition: Pt. A Approved in Referendum 11/04/97 (In favor: 236,170; Opposed: 107,523); Pt. B Approved in Referendum 06/09/98 (In favor: 91,816; Opposed: 45,781).
