An Act to Allow the Department of Inland Fisheries and Wildlife to Create Lifetime Fishing and Hunting Licenses. Presented by Representative CHICK of Lebanon; Cosponsored by Senator HALL of Piscataquis and Representatives: CLUKEY of Houlton, CROSS of Dover-Foxcroft, LABRECQUE of Gorham, NASS of Acton, PERKINS of Penobscot, WHEELER of Bridgewater, Senators: KIEFFER of Aroostook, MacKINNON of York.
