Referred to Joint Standing Committee on State and Local Government. Public Hearing 02/10/97. House: Indefinitely Postponed 04/30/97; Senate: Minority (ONTP) Accepted 04/15/97. Final Disposition: Died in Concurrence 04/30/97.
