Presented by Representative BERRY of Livermore; Cosponsored by Representatives: BUNKER of Kossuth Township, JONES of Bar Harbor, SAMSON of Jay, TOWNSEND of Portland, Senator: CLEVELAND of Androscoggin. Referred to Joint Standing Committee on Agriculture, Conservation and Forestry. Public Hearing 02/18/97. Majority (OTP-AM) Accepted 05/07/97. Amended by: CA H-264. House: Adhere to Failed Enactment 05/15/97; Senate: Enacted 05/15/97. Final Disposition: Died Between Houses 05/15/97.
