RESOLUTION, Proposing an Amendment to the Constitution of Maine to Clarify Voting Rights. Presented by Representative BRENNAN of Portland; Cosponsored by Senator MILLS of Somerset and Representatives: BRUNO of Raymond, CAMERON of Rumford, KANE of Saco, O'NEIL of Saco, SHIAH of Bowdoinham, TOWNSEND of Portland, Senators: DAGGETT of Kennebec, HARRIMAN of Cumberland. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 03/11/97. OTP-AM Accepted 04/07/97. Amended by: CA H-129. Finally Passed, Signed 06/11/97, CON RES LAWS, Chapter 1. Final Disposition: Failed in Referendum 11/04/97 (In favor: 141,654; Opposed: 196,662).
