An Act Regarding the Self-governance of Biddeford Pool. Presented by Representative JOYCE of Biddeford; Cosponsored by Senator AMERO of Cumberland and Representatives: BUCK of Yarmouth, JOYNER of Hollis, KASPRZAK of Newport, LANE of Enfield, PERKINS of Penobscot, SAVAGE of Union, WINSOR of Norway, Senator: KILKELLY of Lincoln. Referred to Joint Standing Committee on State and Local Government. Public Hearing 03/03/97. House: Indefinitely Postponed 05/27/97; Senate: Majority (ONTP) Accepted 05/28/97. Final Disposition: Died in Concurrence 05/28/97.
