Referred to Joint Standing Committee on Health and Human Services. Public Hearing 03/10/97. Majority (OTP-AM) Accepted 04/15/97. Amended by: CA S-89. House: Adhere to Indefinitely Postponed 05/02/97; Senate: Insist on Engrossed as Amended by CA 05/01/97. Final Disposition: Died Between Houses 05/02/97.
