An Act to Authorize the Issuance of a Credit Card to Benefit the Scholarships for Maine Fund. Presented by Representative DAVIDSON of Brunswick; Cosponsored by Senator ABROMSON of Cumberland and Representatives: BRUNO of Raymond, CAMERON of Rumford, CARLETON of Wells, KONTOS of Windham, PERRY of Bangor, SAXL of Bangor, SAXL of Portland, STEVENS of Orono. Referred to Joint Standing Committee on Banking and Insurance. Public Hearing 03/06/97. Majority (OTP-AM) Accepted 03/26/97.
