An Act to Strengthen the Sanctions for Failure to Respond to an Employee's Request for Reason for Termination of Employment. Presented by Senator CLEVELAND of Androscoggin; Cosponsored by Senators: CATHCART of Penobscot, TREAT of Kennebec, Representatives: BOLDUC of Auburn, HATCH of Skowhegan, LEMAIRE of Lewiston, SAMSON of Jay. Referred to Joint Standing Committee on Labor. Public Hearing 03/06/97. Majority (OTP-AM) Accepted 05/19/97. Amended by: CA S-236. Final Disposition: Enacted, Signed 05/31/97, PUBLIC LAWS, Chapter 356.
