An Act to Create a Permanent Funding Source for the Saco River Corridor Commission. Presented by Representative O'NEIL of Saco; Cosponsored by Senator LIBBY of York and Representatives: CHIZMAR of Lisbon, GREEN of Monmouth, KANE of Saco, KONTOS of Windham, McALEVEY of Waterboro, MURPHY of Kennebunk, O'NEAL of Limestone, Senator: PENDLETON of Cumberland. Jointly referred to Joint Standing Committee on Natural Resources and Joint Standing Committee on Taxation. Public Hearing 03/24/97. Majority (OTP-AM) Accepted 05/12/97. Amended by: CA H-396, HA/CA H-598. Final Disposition: Enacted, Signed 05/30/97, PUBLIC LAWS, Chapter 330.
