Referred to Joint Standing Committee on Labor. Public Hearing 04/03/97. Majority (OTP-AM) Accepted 03/31/98. Amended by: CA H-1005, SA/CA S-639. Enacted 04/08/98. Final Disposition: Veto Sustained 04/08/98.
