An Act to Allow the Separation of Frye Island from the Town of Standish. Presented by Representative MACK of Standish; Cosponsored by Senator BUTLAND of Cumberland and Representatives: BRUNO of Raymond, BUMPS of China, KASPRZAK of Newport, KONTOS of Windham, LABRECQUE of Gorham, Senators: AMERO of Cumberland, O'GARA of Cumberland. Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/16/97. Minority (OTP-AM) Accepted 05/23/97. Amended by: CA H-602. Final Disposition: Enacted, Signed 06/10/97, P & S LAWS, Chapter 41.
