Referred to Joint Standing Committee on Banking and Insurance. Public Hearing 04/07/97. Re-referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 02/18/98. House: Majority (OTP-AM) Accepted 03/09/98, Adhere to Engrossment 03/12/98; Senate: Minority (ONTP) Accepted 03/11/98, Adhere to Minority (ONTP) 03/13/98. Final Disposition: Died Between Houses 03/13/98.
