An Act to Require Tobacco Manufacturers to Disclose Ingredients Contained within Tobacco Products. Presented by Senator MILLS of Somerset; Cosponsored by Senator NUTTING of Androscoggin Senator TREAT of Kennebec. Referred to Joint Standing Committee on Health and Human Services. Public Hearing 04/08/97. House: Indefinitely Postponed 03/05/98, Senate: Majority (ONTP) Accepted 03/04/98. Final Disposition: Died in Concurrence 03/05/98.
