An Act to Restructure the State's Electric Industry. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative JONES of Bar Harbor; Cosponsored by Senator CAREY of Kennebec and Representatives: DONNELLY of Presque Isle, LaVERDIERE of Wilton, MITCHELL of Vassalboro, O'NEAL of Limestone, TAYLOR of Cumberland, VEDRAL of Buxton, Senators: AMERO of Cumberland, CLEVELAND of Androscoggin. Referred to Joint Standing Committee on Utilities and Energy. Public Hearing 04/28/97. Majority (OTP-AM) Accepted 05/22/97. Amended by: CA H-568.
