LD 1813 / SP0612

An Act to Authorize a General Fund Bond Issue in the Amount of \$10,000,000 to Address Federal and State Accessibility and Public Safety Issues. (GOVERNOR'S BILL). Presented by Senator CATHCART of Penobscot; Cosponsored by Representative STEVENS of Orono and Senators: BENNETT of Oxford, JENKINS of Androscoggin, LIBBY of York, MICHAUD of Penobscot, Representatives: DONNELLY of Presque Isle, DUNLAP of Old Town, KERR of Old Orchard Beach, KNEELAND of Easton. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/29/97. Majority (OTP-AM) Accepted 05/27/97. Amended by: CA S-329. Enacted, Signed 06/20/97, P & S LAWS, Chapter 58. Final Disposition: Approved in Referendum 11/04/97 (In favor: 188,522; Opposed: 152,736).
