An Act to Establish a System of Tax Revenue Targeting. (GOVERNOR'S BILL). Presented by Senator RUHLIN of Penobscot; Cosponsored by Representative DONNELLY of Presque Isle and Senator BENNETT of Oxford, Representatives: CIANCHETTE of South Portland, DAVIDSON of Brunswick, DEXTER of Kingfield, GAGNON of Waterville, KERR of Old Orchard Beach, SPEAR of Nobleboro. Referred to Joint Standing Committee on Taxation. Public Hearings 05/08/97, 01/26/98. Final Disposition: Minority (ONTP) Accepted 04/02/98.
