LD 1825 / SP0622

An Act to Authorize a Tuition Savings Plan to Encourage Attendance at Institutions of Higher Education. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Senator PENDLETON of Cumberland; Cosponsored by Representative KONTOS of Windham and Senators: BENNETT of Oxford, HALL of Piscataquis, Representatives: CAMERON of Rumford, CLARK of Millinocket, DESMOND of Mapleton, MURPHY of Kennebunk, TUTTLE of Sanford, USHER of Westbrook. Referred to Joint Standing Committee on Education and Cultural Affairs. Public Hearing 01/28/98. Majority (OTP-AM) Accepted 03/30/98. Amended by: CA S-620. Final Disposition: Enacted, Signed 04/13/98, PUBLIC LAWS, Chapter 732.
