LD 1829 / SP0627

An Act to Change the State's Fiscal Year from July 1st to October 1st. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.)

Presented by Senator PINGREE of Knox; Cosponsored by Representative KONTOS of Windham and Senators: CLEVELAND of Androscoggin, LAWRENCE of York, MICHAUD of Penobscot, RAND of Cumberland, Representatives: MITCHELL of Vassalboro, SAXL of Portland. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 05/06/97. House: Majority (ONTP) Accepted 03/31/98, Adhere to Majority (ONTP) 04/03/98; Senate: Minority (OTP-AM) Accepted 03/27/98, Insist on Engrossment 03/31/98. Final Disposition: Died Between Houses 04/03/98.
